Explanation of Responses:

- Exercise of stock options. Following the exercise, these shares were converted into American Depositary Shares ("ADS") of the Issuer. Each ADS represents twelve ordinary shares of the Issuer.
- Converted from British Pounds Sterling to U.S. Dollars using currency ratio of 1.00 British Pound Sterling = 1.26 U.S. Dollars as of June 3, 2019.
- Represented by ADSs. The sales reported were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on May 20, 2019.
- The price reported in Column 4 is a weighted average price per ordinary share (\$175.35 per ADS). These shares were sold in multiple transactions at prices ranging from \$175.04 per ADS (or \$14.59 per ordinary share) to \$175.64 per ADS (or \$14.64 per ordinary share), inclusive.
