**Explanation of Responses:**

- Exercise of stock options. Following the exercise, these shares were converted into American Depositary Shares ("ADS") of the Issuer. Each ADS represents twelve ordinary shares of the Issuer.
- Converted from British Pounds Sterling to U.S. Dollars using currency ratio of 1.00 British Pound Sterling = 1.27 U.S. Dollars as of May 24, 2019.
- Represented by ADSs. The sales reported were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on May 9, 2019.
- The price reported in Column 4 is a weighted average price per ordinary share (\$182.00 per ADS). These shares were sold in multiple transactions at prices ranging from \$181.56 per ADS (or \$15.13 per ordinary share) to \$182.54 per ADS (or \$15.21 per ordinary share), inclusive. The Reporting Person undertakes to provide to the Issuer, any security holder of the Issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range.
- The price reported in Column 4 is a weighted average price per ordinary share (\$183.18 per ADS). These shares were sold in multiple transactions at prices ranging from \$182.58 per ADS (or \$15.22 per ordinary share) to \$183.54 per ADS (or \$15.30 per ordinary share), inclusive. The Reporting Person undertakes to provide to the Issuer, any security holder of the Issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range.

6. The price reported in Column 4 is a weighted average price per ordinary share (\$183.78 per ADS). These shares were sold in multiple transactions at prices ranging from \$183.58 per ADS (or \$15.30 per ordinary share) to \$184.15 per ADS (or \$15.35 per ordinary share), inclusive. The Reporting Person undertakes to provide to the Issuer, any security holder of the Issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range.

7. The price reported in Column 4 is a weighted average price per ordinary share (\$185.88 per ADS). These shares were sold in multiple transactions at prices ranging from \$185.40 per ADS (or \$15.45 per ordinary share) to \$186.20 per ADS (or \$15.52 per ordinary share), inclusive. The Reporting Person undertakes to provide to the Issuer, any security holder of the Issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range.

8. The price reported in Column 4 is a weighted average price per ordinary share (\$186.99 per ADS). These shares were sold in multiple transactions at prices ranging from \$186.58 per ADS (or \$15.55 per ordinary share) to \$187.43 per ADS (or \$15.62 per ordinary share), inclusive.
